



ACKNOWLEDGMENT OF RISK STATEMENT

The Passages orientation program you are about to participate in will be challenging, rewarding, and fun, but you should be aware of risks inherent in such activities.

The Passages Immersive Experiences that include day hikes, paddling, backpacking, climbing, community service, and overnight trips all involve an inherent risk of injury or illness.

If you choose to participate in a backpacking Immersive Experience (three-day, two-night backpacking trip), you will carry a backpack weighing approximately 30–50 pounds up and down rocky mountain trails and possibly crossing streams. This can aggravate even minor physical problems, such as weak knees, ankles, or vertebrae. It is important that you are accustomed to handling some physical stress. Participants should be mindful of their well-being and seriously consider whether they are physically and mentally fit to withstand the physical and/or mental stress involved. It is possible that you will experience fatigue, blisters, and minor cuts and scrapes. Although less likely, other possible adverse health effects include heat exhaustion, sprains, broken bones, or other accidents, illness, or injury.

Activities may take place in the Olympic Mountains, which generally have pleasant weather in late summer, but rain, snowstorms, and freezing temperatures can occur, resulting in temporary discomfort and increasing the risk of hypothermia. Although Passages Leaders are trained in first aid, and area search and rescue personnel will be aware of our presence, medical facilities are remote, and wilderness evacuation is involved and time consuming. Backpacking trip leaders will have cellular phones, however, they may not be a reliable in all situations. They do carry satellite phones, however, satellite orbit, weather conditions, and geography can interfere with communication and make these devices less than reliable.

If you participate in immersive experiences from campus or car camping, the risks are fewer. Depending on the involvement you choose in activities such as day hikes in the mountains or water activities, many of the considerations mentioned above apply, but over a shorter duration. Passages Leaders facilitating activities will have cellular phones, however, they may not be a reliable in all situations.

Immersive Experiences may require that you travel in a bus, in a van, or on foot in a variety of conditions with the Passages Leader. There are inherent dangers and risks involved in any sort of travel, and we ask that you be aware of those dangers and act wisely.

We firmly believe that the benefits of this program far outweigh the potential risks. Accidents occur much less frequently when adequate preparation is accompanied by sound judgment. You, however, must take a very active role in maximizing your chances for success, safety and minimizing risks.

To ensure that you have familiarized yourself with the dangers involved, we ask that you do the following:

1. Read and understand the information on the Acknowledgment of Risk Statement and the Release and Waiver of Liability, Assumption of Risk, and Indemnity Agreement—Overnights, Paddling, Community Service, Hiking, Climbing, or Backpacking. If you have questions, call us at 253-879-3322.
2. Follow the supplied equipment and clothing lists exactly. Many wilderness accidents occur because people do not bring the proper equipment and clothing, and/or underestimate the extreme weather conditions that can suddenly occur in the Pacific Northwest. This endangers not only you, but the safety of others in your group as well.
3. Take responsibility for your physical fitness. Although the Orientation program is designed to accommodate many levels of physical ability, you should choose your level of involvement wisely. Be honest with yourself and with us about what types of Immersive Experiences you can handle.
4. Follow the advice of Passages Leaders. These students and staff members are eager to help you have a successful and meaningful experience, and have been trained in wilderness first aid and safety.

**RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK,
AND INDEMNITY AGREEMENT:
Overnights, Paddling, Community Service, Hiking, Climbing, or Backpacking**

I, _____ (“Participant”) (or on behalf of my minor child), hereby acknowledge that I have voluntarily elected to participate in the University of Puget Sound Passages Orientation Program Immersive Activities (“Activity”) to be held in and around the Puget Sound region, Olympic Peninsula, Olympic National State Park, or the Olympic Mountains, between August 21, 2021, through August 29, 2021. I acknowledge that my participation is elective and voluntary.

In consideration for being permitted by the University of Puget Sound (“Puget Sound”) to participate in the Activity which may include: overnight travel; camping under tents or tarps; car camping; bicycling; climbing, introductory, moderate, or strenuous backpacking with backpacks weighing up to 45-55 pounds; canoeing; sea kayaking; paddling; swimming; base camp activities; community service activities; and/or day hikes, I hereby acknowledge and agree to the following:

PROMOTIONAL RIGHTS: As a condition of my participation, I hereby grant Puget Sound the right to use, for promotional purposes only, any photographs of me taken by Puget Sound, its employees or agents, during my participation in the Activity. I further understand and agree that Puget Sound may use (for marketing purposes) any statements or quotes attributed to me in my evaluation of the Activity.

RULES AND REQUIREMENTS: I agree to conduct myself in accordance with Puget Sound’s policies and procedures. I further agree to abide by all the rules and requirements of the Activity and the rules listed in Puget Sound’s [Code of Conduct](#), [Student Handbook](#), and [campus-wide policies](#). I acknowledge that Puget Sound has the right to terminate my participation in the Activity if it is determined that my conduct is detrimental to the best interests of the Activity, my conduct violates any rules of the Activity or Puget Sound, or at Puget Sound’s discretion. I understand that in the event my participation in the Activity is terminated, I may be solely responsible for the cost of return travel.

SPECIFIC INFORMATION RELATED TO COVID-19. The novel coronavirus, COVID-19, is a worldwide pandemic. The state of medical knowledge is evolving, and the virus continues to be a risk. Evidence has shown that COVID-19 can cause serious and potentially life threatening illness and even death. Puget Sound cannot assure that you will not become exposed to, contract, or spread COVID-19 while participating in the Activity. Therefore, if you choose to participate in the Activity you may expose yourself to and/or increase your risk of contracting or spreading COVID-19. By signing this release, you acknowledge you have read and understood the above warning concerning COVID-19, that you have determined that there is value to you participating in the Activity, and that you are voluntarily assuming the risk of exposure to or contracting COVID-19.

INFORMED CONSENT: I have been informed of and I understand the various aspects of the Activity. I understand that as a Participant in the Activity, I will engage in physical activities that involve or may involve inherently dangerous activities, including, but not limited to: overnight travel, the hazards of traveling in mountainous terrain or on water, accidents or illness in remote places without medical facilities, physical exertion, bodies of water, heights, climbing, use of third party venues, community service work, camping under tents or tarps overnight, car

camping, weather conditions, close proximity to wildlife, travel by canoe or kayak, travel on foot, travel on bicycle, and travel by vehicle.

As with any inherently dangerous activity involving overnight travel, the hazards of traveling in mountainous terrain or on water, accidents or illness in remote places without medical facilities, physical exertion, bodies of water, heights, climbing, use of third party venues, community service work, camping under tents or tarps overnight, car camping, weather conditions, close proximity to wildlife, travel by canoe or kayak, travel on foot, travel on bicycle, and travel by vehicle, I understand that certain risks are inherent to personal health, safety and/or property therewith and that I could sustain including, but not limited to, serious bodily injuries including serious injury to virtually all bones, joints, muscles, and internal organs, cardiac problems, brain damage, illness, damage, or even death as a consequence of my participating in the Activity, and that protective equipment or preventative measures may be inadequate to prevent serious injury. These serious personal injuries and possible death may not only be a consequence of Releasees' (as defined herein) actions, inactions, negligence, or fault, but also the actions, inactions, negligence, or fault of others, conditions of equipment used, facility conditions, weather conditions, negligent first aid operations and procedures, and other risks not known to me or not reasonably foreseeable at this time. I further understand and agree that any injury, illness, damage, disability, or death that I may sustain by any means is my sole responsibility, except as explicitly specified in this Agreement.

I understand that my safety is ultimately my own responsibility and that I am responsible for furnishing my own proper clothing and equipment, except for items of equipment I have indicated that I will rent from Puget Sound. I understand that I am responsible for the safety and good operating condition of all equipment, regardless of where I obtain it. I understand that Activity leaders will have cellular phones, however, they may not be reliable in all situations. Activity leaders will also carry satellite phones, however, satellite orbit, weather conditions, and geography can interfere with communication and make these devices less than reliable.

I further understand that the Activity in which I am participating involves or may involve bodies of water. I am aware that any contact with bodies of water involves certain risks, including, but not limited to: death, drowning, or other personal injury as a result of the area's conditions, the acts of third parties or other unknown safety hazards, diving injury, skin, eye, lung, and ear irritation, injuries resulting from loss of balance and footing on aquatic surfaces, injuries resulting from lack of oxygen, injuries due to conditions of equipment, unpredictability of weather and the water conditions, wildlife, first aid operations, or procedures of Releasees (as defined herein) and/or others, contagious disease, and that there may be other risks not known to me or not reasonably foreseeable at this time.

I have been informed and I understand that the Activity in which I am participating involves or may involve overnight travel. I am aware that travel, including overnight travel and accommodations, involves certain risks, including but not limited to: serious personal injuries, illness, assault, property damage and theft, or even death as a consequence. These injuries may be the result of my own actions or inactions or those of others, conditions of transportation or accommodations, weather conditions, negligent first aid operations and procedures, and other risks not known to me or not reasonably foreseeable at this time. I further understand and agree that any injury, illness, damage, disability, or death that I may sustain by any means is my sole responsibility, except as explicitly specified in this Agreement.

ASSUMPTION OF RISK: I understand and acknowledge that there are potential dangers incidental to my participation in the Activity, including risks of property damage or loss, damage,

bodily injury, illness, and possibly death as described throughout this Agreement. The risks may result from the Activity itself, from the acts of others, from use of any equipment, or organization of or unavailability of emergency medical care. I understand that there are risks attendant to physical activities associated with the Activity and that there are potential dangers which may expose me to the risk of personal injuries, illness, damage, or even death. In addition, I understand that participation in the Activity involves activities incidental thereto, including, but not limited to, travel to and from the site of the Activity, participation at sites that may be remote from available medical assistance, and the possible reckless conduct of other participants. I understand that these potential risks include, but are not limited to: travel to and from Puget Sound's campus via private vehicles, common carriers, and/or Puget Sound owned vehicles, local transportation to and from the Puget Sound region, Olympic Peninsula, Olympic National State Park, or the Olympic Mountains, weather conditions, facility conditions, equipment conditions, negligent first aid operations or procedures of Releasees (as defined herein), the spread of contagious disease, and that there may be other risks not known to me or not reasonably foreseeable at the time.

I KNOWINGLY AND VOLUNTARILY ASSUME ALL SUCH RISKS, BOTH KNOWN AND UNKNOWN, EVEN IF ARISING FROM THE ACTS OF THE RELEASEES, UNLESS THE RISKS ARISE SOLELY FROM THE RELEASEES' NEGLIGENCE, GROSS NEGLIGENCE, OR INTENTIONAL MISCONDUCT and I assume full responsibility for my participation in the Activity.

RELEASE AND WAIVER OF LIABILITY: I, on behalf of myself, my personal representatives, heirs, executors, administrators, agents, and assigns, **HEREBY RELEASE, WAIVE, DISCHARGE, AND COVENANT NOT TO SUE** the University of Puget Sound, including its governing board, trustees, directors, officers, employees, and any Participants, agents, or volunteers acting at Puget Sound's direction (collectively referred to as "Releasees"), for any and all liability, including any and all claims, demands, causes of action (known or unknown), suits, or judgments of any and every kind (including attorneys' fees), arising from any property damage or loss, injury, illness, damage, or death that I may suffer as a result of my participation in the Activity, **REGARDLESS OF WHETHER THE INJURY, ILLNESS, DAMAGE, OR DEATH IS CAUSED BY THE RELEASEES, UNLESS THE INJURY, ILLNESS, DAMAGE, OR DEATH IS CAUSED SOLELY BY THE RELEASEES' NEGLIGENCE OR GROSS NEGLIGENCE OR INTENTIONAL MISCONDUCT, AND REGARDLESS OF WHETHER THE INJURY, ILLNESS, DAMAGE, OR DEATH OCCURS WHILE IN, ON, UPON, OR IN TRANSIT, INCLUDING OVERNIGHT STAY, TO OR FROM THE PREMISES WHERE THE ACTIVITY, OR ANY LOCATION ADJUNCT TO THE ACTIVITY, OCCURS OR IS BEING CONDUCTED.**

I further agree that the Releasees are not in any way responsible for any property damage or loss, injury, illness, or damage that I sustain as a result of my own negligent or grossly negligent acts, or my own intentional misconduct and I hereby release Releasees from any liability for the same.

Puget Sound expressly disclaims liability for actions of third parties, which includes but is not limited to Participants, agents, or volunteers who are not acting under the direction and control of Puget Sound. I hereby release Releasees from any and all liability, including any and all claims, demands, causes of action (known or unknown), suits, or judgments of any and every kind (including attorneys' fees), arising from any property damage or loss, injury, illness, damage, or death that I may suffer as a result of actions of any third parties who are not Releasees.

INDEMNITY: I, on behalf of myself, my personal representatives, heirs, executors, administrators, agents, and assigns, agree to hold harmless the Releasees from any and all liability, including any and all claims, demands, causes of action (known or unknown), suits, or

judgments of any and every kind (including attorneys' fees), arising from any property damage or loss, injury, illness, damage, or death that I may suffer as a result of my participation in the Activity, **REGARDLESS OF WHETHER THE INJURY, ILLNESS, DAMAGE, OR DEATH IS CAUSED BY THE RELEASEES OR OTHERWISE, UNLESS THE INJURY, DAMAGE, OR DEATH IS SOLELY CAUSED BY THE RELEASEES' NEGLIGENCE, GROSS NEGLIGENCE, OR INTENTIONAL MISCONDUCT.**

I further agree that, in the event that I or any of my family members, personal representatives, heirs, executors, administrators, agents, assigns or any other third party attempts to assert any claims, demands, causes of action (known or unknown), suits, or judgments of any and every kind (including attorneys' fees), arising from any property damage or loss, injury, illness, damage, or death to me, including, but not limited to, any injury resulting from my own negligence, gross negligence, or intentional misconduct during or related to the Activity, **I AGREE TO DEFEND AND INDEMNIFY RELEASEES AGAINST SUCH CLAIMS, DEMANDS, CAUSES OF ACTION (KNOWN OR UNKNOWN), SUITS, AND/OR JUDGMENTS OF ANY AND EVERY KIND (INCLUDING ATTORNEYS' FEES) to the fullest extent permitted by Law.**

PERSONAL MEDICAL INSURANCE: I further acknowledge that I am responsible for the cost of any and all medical and health services I may require while participating in the Activity or as a result of participating in the Activity, except for medical costs arising from an injury or illness that I sustain that is the direct result of Releasees' negligence or gross negligence or intentional misconduct. I understand and agree that Releasees shall not in any way be responsible for other contingent losses arising from any injury or illness I sustain that is not the result of Releasees' negligence, gross negligence, or intentional misconduct.

CERTIFICATION OF FITNESS TO PARTICIPATE: I attest that I am physically and mentally fit to participate, including being free of symptoms of communicable disease, including COVID-19, in the Activity and that I do not have any medical record of history that could be aggravated by my participation in the Activity. I further attest I am responsible for consulting with my health care provider towards this end.

RESPONSIBILITY FOR REPORTING INJURIES: I acknowledge that I must be an active participant in my own healthcare and as such, it is my responsibility to report all injuries and illnesses, including signs and symptoms of concussions, to a Passages Leader.

MEDICAL CONSENT: I understand and agree that Releasees may not have medical personnel available at the location of the Activity. In the event of any medical emergency, I (initial one) **do ___/do not ___** authorize and consent to any x-ray examination, anesthetic, medical, dental, or surgical diagnosis or treatment and hospital care that Puget Sound personnel deem necessary for my safety and protection. I understand and agree that Releasees assume no responsibility for any injury, illness, or damage which might arise out of or in connection with such authorized emergency medical treatment. I further understand that in the event that I experience any condition requiring emergency medical treatment, Puget Sound may direct that I be transported to the hospital for such care.

NON-EMPLOYEE STATUS: I understand and acknowledge that in participating in the Activity, I am doing so independently and that I am not an employee or agent of Puget Sound. I understand and agree that as a non-employee, I am not entitled to receive compensation or any other employee benefit from Puget Sound for my participation in the Activity.

CHANGE OF VENUE: Puget Sound reserves the right to change the venue to a similar venue and/or to change the dates of the Activity if the original venue is not available on the originally planned date. Such change of venue or schedule shall not void this Agreement.

CHOICE OF LAW: I hereby agree that this Agreement shall be construed in accordance with the laws of the State of Washington.

SEVERABILITY: If any term or provision of this Agreement shall be held illegal, unenforceable, or in conflict with any law governing this Agreement the validity of the remaining portions shall not be affected thereby.

I hereby acknowledge that I have read, understand, and will abide by each of the terms and conditions of this Agreement. I understand that I may seek legal counsel of my own choosing to fully explain any terms of this Agreement to me before I sign it.
