

Summary Annual Report

This is a summary of the annual report for the UNIVERSITY OF PUGET SOUND RETIREMENT SAVINGS PLAN, (Employer Identification No. 91-0564961, Plan No. 001) for the period July 1, 2021 to June 30, 2022. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

BASIC FINANCIAL STATEMENT

Benefits under the plan are provided by a trust (benefits are provided in whole from trust funds). Plan expenses were \$17,035,236. These expenses included \$70,822 in administrative expenses and \$16,964,414 in benefits paid to participants and beneficiaries. A total of 2,198 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, was \$300,422,536 as of June 30, 2022 compared to \$342,680,328 as of July 1, 2021. During the plan year the plan experienced a decrease in its net assets of \$42,257,792. This decrease includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year, or the cost of assets acquired during the year. The plan had total income of \$-25,222,556, including employer contributions of \$24,63,388, employee contributions of \$3,169,778, other contributions of \$794,148, earnings from investments of \$-31,737,710 and other income of \$87,840.

The plan has a contract with TIAA-CREF which allocates funds toward individual policies.
