# Status of Previous Recommendations Addressed in this Evaluation

Finding Type 1: Spring 2024 Policies, Regulations, and Financial Review - Fulfilled

#### Commendations

The Commission commends University of Puget Sound for:

- 1. Its culture of highly collaborative decision-making structures and processes. This inclusive planning environment was evident in meetings with students, faculty, staff, administration, and members of the Board of Trustees.
- 2. Implementing experiential learning as a degree requirement. The Logger Experiential Commitment ensures that all undergraduate students have at least one high-impact practice as part of their Puget Sound journey.
- 3. The Freedom Education Project Puget Sound. This effort to provide an opportunity for incarcerated students to earn a degree through the University of Puget Sound is an outstanding application of the university's mission.

# Recommendations Substantially in Compliance but in Need of Improvement

The Commission recommends that University of Puget Sound:

- Recommendation 1: Spring 2025 Evaluation of Institutional Effectiveness Establish a systematic
  process for assessing institutional effectiveness that includes meaningful indicators of student
  learning and achievement to inform strategies for improvement and resource allocation. (2020
  Standard(s) 1.B.1; 1.D.4)
- Recommendation 2: Spring 2025 Evaluation of Institutional Effectiveness Develop and implement a system to directly measure program learning outcomes and use those assessment results to improve programs and learning-support practices. (2020 Standard(s) 1.C.5; 1.C.7)
- Recommendation 3: Spring 2025 Evaluation of Institutional Effectiveness Systematize their approach to assessing institutional learning outcomes in a manner that aligns with their curriculum and degree requirements. (2020 Standard(s) 1.C.6)
